National plan and strategies
<p>1. CYPRUS ASYLUM SERVICE (It is a service of Cyprus government which decides and implement the national plan for refugees)</p> <p>Briefly, the Cypriot legislation on asylum provides that the Asylum Service of the Ministry of Internal Affairs examines the applications for international protection of refugees, while the Refugee Reviewing Authority examines asylum seekers whose applications are rejected.
